Ref: Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations')

Pursuant to Regulation 30 of the Listing Regulations read with Para B of Part A of Schedule III of the Listing Regulations, this is to inform you that the Company was issued Orders by the Office of the Principal Commissioner of Customs, Chennai-III, dated 15 December 2025.

This is with reference to the announcement made on BSE Listing dated 21.01.2026 regarding the imposition of penalty by the Customs Authority in the above-mentioned matter.

In this regard, we would like to respectfully submit that, as per the order referred to in the announcement, the operative part imposing the penalty is specifically applicable to "Sree Jayalakshmi Autospin Private Limited" and the said operative portion does not impose any penalty or liability on "Sree Jayalakshmi Autospin Limited".

Accordingly, it is clarified that Sree Jayalakshmi Autospin Limited is not the entity on which the penalty has been imposed under the said order. The operative directions are applicable only to the Private Limited entity referred to in the order and not to our Limited company.

That without prejudice it is submitted that present board of directors are not involved in any kind of transactions or acts in any manner as alleged and further pertains to time period when present board of directors were not part of it. The entire allegations being attributed to company are without any cogent and substantive proof based on statements given by strangers & third persons not associated with company in any manner and there are no documentary proofs.
